**NARRATIVE**

On the 14th day of October, 2015 at 11:51 a.m., I, Officer Darren Baker along with Major Jason Broady, Officer Tim Wolff and Officer Adam Clark were dispatched to 134 Winthrope Ave in reference to domestic. The dispatcher advised that one party involved has an AR style rifle. Upon arrival, I was met by a white male running down the street toward my police car. I exited my police car and began speaking with the male subject identified as Richard Hambrick. Officers Broady, Wolff and Clark went to 134 Winthrope to speak with the other people involved and several witnesses.

Richard advised that he recently split up with his boyfriend James Howell. Richard stated he was given a trespass warning from a previous case to stay away from 134 Winthrope. Richard stated today however, our friend Shawn Logsdon told me to come to the edge of the yard and he would bring out my remaining property and give it to me. Richard stated, "So, I walked down to James' house and stood in the yard to get my stuff". Richard stated that is when James came out with a AR rifle and pointed at me telling me to leave". Richard stated, "James told me if I stepped foot in his yard, he would kill me". Richard stated, "I told him to shoot me and then I left the front of the residence and walked down the street".

I then spoke to Tina Golightly. Tina stated Richard came to my house and was hanging out. Then he went down the street at James' residence to retrieve his belongings. Tina stated Richard did not go in James' yard. Tina stated, "I seen the two starting to argue and that is when James came out of the house and pointed a rifle at Richard".

I then spoke with James Howell. James stated he has had an on going problem with Richard and his mother coming over and in to my house arguing with me. James stated, "Richard has been given a trespass warning to my residence". James stated, "Richard kept raising his arms to me in an aggressive manner as if he was wanting me to fight me". James pointed toward a concrete water fountain in his yard and stated that is where Richard was standing. NOTE: The fountain was about halfway in his yard between the house and the road. James stated, "I told him to leave my yard and that is when I grabbed one of my rifles and held the gun up on my shoulder and continued to ask Richard to leave my yard". James stated, "I kept the gun pointing toward the sky up on my shoulder".

Officer Tim Wolff spoke with witnesses Grace and Shawn Logsdon. They both stated that James did not point the gun toward Richard. They both stated James only held the gun on his shoulder while he was asking Richard to leave.
